## **TSLEIL-WAUTUTH NATION**

## AMENDMENT #1 TO 'TSLEIL-WAUTUTH NATION LAND USE PLAN LAW 2019

**WHEREAS** we the Chief and Council of the Tsleil-Waututh Nation (the "Nation") enacted the *Tsleil-Waututh Nation Land Use Plan Law 2019* on January 22, 2019 pursuant to the Nation Land Code;

**AND WHEREAS** the Chief and Council of the Nation deem it advisable and in the best interests of the Nation to amend Appendix 1, titled Land Use Plan Map, of Schedule A of the Law;

AND WHEREAS the Tsleil-Waututh Nation ("TWN") has taken control of the management of its reserve lands and resources pursuant to the Framework Agreement on First Nation Land Management and the First Nations Land Management Act, S.C. 1999, c. 24, and has enacted the Tsleil-Waututh Nation Land Code ("Land Code") which came into force and effect on June 6, 2007;

**AND WHEREAS** the *Tsleil-Waututh Nation Land Use Plan Law 2019* states in Part 2 – Section 12 as follows:

Council shall amend this Law in accordance with this Part.

**NOW THEREFORE** the Council of the Tsleil-Waututh Nation hereby enacts an amendment to the *Tsleil-Waututh Nation Land Use Plan Law 2019* pursuant to Part 2 Amendment Procedures of the *Tsleil-Waututh Nation Land Use Plan Law 2019* to amend *Tsleil-Waututh Nation Land Use Plan Law 2019* as follows:

- 1. The *Tsleil-Waututh Nation Land Use Plan Law 2019* is hereby amended as follows:
  - a. Appendix 1, titled Land Use Plan Map, of Schedule A is deleted in its entirety and replaced with the document attached hereto as Appendix 1.
- 2. This law may be cited as the TWN LUP Law Map Amendment #1, 2019.
- 3. This law comes into place and takes effect on the date of its enactment.
