TSLEIL WAUTUTH NATION (BURRARD INDIAN BAND) A BY-LAW TO AMEND THE WATERWORKS BY-LAW 2001

WHEREAS we the Chief and Council of the Tsleil Waututh Nation, also known as the Burrard Indian Band (the "Nation") enacted the Tsleil Waututh Nation Waterworks By-law 2001 (the "By-law") on December 19, 2001.

AND WHEREAS the Minister of Indian Affairs and Northern Development approved the By-law on February 20, 2002.

AND WHEREAS the Chief and Council of the Nation deem it advisable and in the best interests of the Nation to further amend the By-law as set out below;

BE IT HEREBY RESOLVED that the Chief and Council of the Nation enact the following by-law amend the By-law pursuant to section 81:

1. That the attached Schedule "B" – Water User Charges is to replace the previous Schedule "B" – Water User Charges.
